63.4.9		New clause added; With reference to the Exception of 12.1.1.3, when an appliance is provided with a detachable cord set, the appliance shall be marked the substance of the following with a warning label "CAUTION – Risk of fire and electric shock. Use only manufacturer's power cord set.". The marking shall be located adjacent to the power supply cord receptacle on the appliance and be included in the manufacturer's literature packaged with the appliance as required in 65.7. When space limitation on the appliance prevents the use of a warning label, a cord tag is acceptable.

65.7		<i>New clause added;</i> With reference to the Exception of 12.1.1.3, when an appliance is provided with a detachable power cord, the manufacturer's literature packaged with the appliance shall include the substance of the following warning "CAUTION – Risk of fire and electric shock. Use only with the original equipment manufacturer's power cord set." The manufacturer shall also provide the recommended power cord set for replacement purpose in the user instructions.
